An Overview of the Opportunities

Purpose of the Programme

The Malta Retirement Programme is specifically designed to attract non-working individuals who primarily receive income from pensions, retirement schemes, or annuities.

Tax Benefits

One of the main advantages of the Malta Retirement Programme is the attractive tax rates offered to applicants and their dependents.

Non-refundable Administrative Fee

A non-refundable administrative fee of €2,500 is required upon application.

Eligibility Criteria

Understanding the Criteria for Residency in Malta

Nationality Requirment

Applicants must not be Maltese nationals. This stipulation ensures that the program is exclusive to foreign individuals seeking residence in Malta.

Property Ownership or Lease

Purchased Property: €275,000 (Malta) & €220,000 (South of Malta or Gozo). **Leased Property:** €9,600/year (Malta) & €8,750/year (South of Malta or Gozo).

Other Requirements Exclusions

- Possesion of a valid travel document and of Health Insurance against all risks across the EU.
- Is not a Maltese National.
- the pension received by the applicant must be fully transferred to Malta and must constitute at least 75% of the total chargeable income.
- Possesion of a valid travel document and of Health Insurance against all risks across the EU.

Exclusions

Individuals must not benefit under the Residents Scheme Regulations, the High Net Worth Individuals Rules, or the Highly Qualified Persons Rules.

Tax and Residency Conditions

Exploring the financial advantages of residing in Malta



Flat Tax Rate

Malta offers a flat tax rate of 15% on foreign income that is remitted to the country.



Minimum Tax Liability

The minimum tax liability for individuals residing in Malta is set at €7,500 annually. Additionally, for each dependent, there is an added tax liability of €500.



Residency Requirement

The beneficiary must reside in Malta for atleast 90 days averaged over any five year period, and must not stay in any other jurisdiction for more than 183 days in any calendar year.
